### GENERAL INFORMATION

The 2nd Annual Alder Golf Classic is named in honor of William R. Alder, Jr., a pioneer and leader in the transformation of the geospatial intelligence community. The tournament is being held at Falcon's Fire Golf Club in Orlando, Florida. Proceeds from the event contribute to the general USGIF Scholarship Fund, which includes a yearly contribution from USGIF to the William R. Alder, Jr. scholarship fund.

The Alder Golf Classic will take place on Monday, November 13, 2006 from 8 a.m. to approximately 4 p.m. Buses will be leaving from the Gaylord Palms and the Caribe Royale at 6:30 a.m. and head directly to Falcon's Fire Golf Club. Upon arrival, participants will check-in at the registration desk, located in front of the pro shop and receive their tournament packet. A light breakfast will be served at Falcon's Nest Restaurant and participants will be given some time to hit balls at the driving range prior to the 8 a.m. shotgun start. Please note, Falcon's Fire Golf Club does not have locker rooms.

Immediately following the tournament, lunch will be served at Falcon's Nest Restaurant. Participants will be given 30 minutes immediately following lunch to shop at the pro shop as the buses will head back to the Gaylord Palms and Caribe Royale.

### SPONSORSHIP / PARTICIPATION OPTIONS

We have several different sponsorship options available.
